Who is this Packet For?

This packet is intended for **Democratic candidates running for partisan offices in Dallas County** who are required to file with the Dallas County Democratic Party during the primary election cycle.

These offices include:

- **County Commissioner**
- **Justice of the Peace**
- **Constable**
- **County Judge**
- **County Clerk**
- **District Clerk**
- **County Sheriff**
- **County Tax Assessor-Collector**
- **County Treasurer**
- **County Court-at-Law Judges**
- **County Criminal Court Judges**
- **Probate Court Judges**
- **Some State Representatives and State Senators**

⚠ *Candidates for federal or statewide offices do **NOT** file with the DCDP. They must file with the Texas Democratic Party or the Secretary of State.*

⚠ *This packet also **DOES NOT** apply to candidates for nonpartisan offices such as City Council, Mayor, or School Board, which file through local municipalities or ISDs.*

Collecting Signatures for Valid Petition

check www.sos.state.tx.us for number of signatures required



Signature Requirements:

- ONE signature per voter per office
 - Name is clearly printed alongside signature
 - MUST include **address**: including street (or mail address if no street address), city, Texas, and ZIP (zip omitted doesn't invalidate)
 - Voter must be resident of **Dallas County**
 - MUST include **Date of Birth** OR Voter Registration Number (VUID)
 - MUST include **Date Signed**
- * See page #6 for example

Make Copies of your signatures!



For your records, you will want to scan and/or copy your signatures before giving to the DCDP to file

File in Person with the DCDP



! You **must** file your application and fee/petition **IN PERSON** with the DCDP

Bring:

- Completed Application for a Place on the Ballot
- Filing fee and/or petition with valid signatures
- Valid form of ID

How to Appoint a Campaign Treasurer

A Guide on Form CTA

? What is Form CTA

- Required form to **appoint a campaign treasurer**
- Must be filed before you raise or spend any campaign funds
- Filing this form **officially makes you a candidate** under Texas law
- ★ You may appoint yourself as your own treasurer

📅 When to File

- Before paying a **filing fee**
- Before **accepting any campaign contributions**
- Before **making any campaign expenditures**, even from personal funds
- Before **submitting an application for a place on the ballot**

📍 Where to File

- County, precinct, or single-county district office → **Dallas County Elections Department**
- State-level office (e.g., State Rep, Governor) → **Texas Ethics Commission**
- School board or other local subdivision office → **Clerk, secretary, or presiding officer of that entity**

☑ What to include

- Candidate and treasurer's **full name, address, and phone number**
- **Office sought**
- Candidate's **signature acknowledging legal responsibilities**
- (Optional) Checkbox to select Modified Reporting

⌂ Modified Reporting Option

- Allows you to **skip pre-election and runoff reports** if you **raise and spend \$1,110 or less per election**
- Must be selected on the **back of Form CTA** at least **30 days before the election**
- Applies **separately** to each election (primary, runoff, general)
- Not available to state or county party chair candidates
- If you go over the \$1,110 limit:
 - File a report within 48 hours
 - Start filing regular reports for rest of election cycle

- ✗ Date signed is in the wrong column, no DOB included
- ✗ Printed name is illegible and scribbled through
- ✗ Incomplete Address (without city or state info)
- ✗ No full name is provided, only initials
